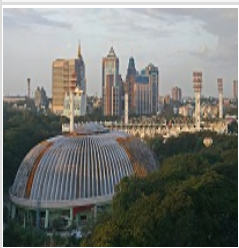

Advance Booking Policy

50 % of the total package cost must be deposited as an advance in our company's account to confirm the package.
 We can also accept the booking at 25 % of total package cost as a token amount if you confirm the desired package before 30 days of your travel date. (NOTE: This policy is not applicable for packages costing above INR 50,000/-)
 Please note that the advance 25% of the payment will be considered as token amount only & will be non refundable. Rest of the 25 % must be cleared before 15 days of Travel Date. Failure in doing so will lead to cancellation of your tour.
 Remaining 50 % of the package cost will be collected on arrival day.
 Customers must carry the issued confirmation letter on their trip as it contains important information like confirmed hotel, Cab Details and Service contact Numbers.
PROCESS OF MAKING ADVANCE PAYMENT:
 One Time Advance Payment: It can be done through our website www.bharatbooking.com by using Net banking/Credit Card/Debit Card and Wallets via EBS, CC-Avenue, HDFC gateway, Paytm etc.

Notes

 Transfers must be followed as per the instructed time of the transporters. In case, customers miss their respective transportation services, alternatives arrangements will attract extra cost.
 Bharat Booking Holidays will not be reliable for any changes made by Third Party Providers i.e. Transportation, Hoteliers etc.
 Bharat Booking shall not be responsible for any delays due to technical faults, Heavy Traffic Jam or unforeseen situations. In "Unforeseen" scenarios extra cost may also be levied over the customers.

Cancellation & Refund Policy

There is no contract between Bharat Booking Holidays India Pvt. Ltd. and the client until the company has received initial deposit amount of specified tour package. In case, customer wishes to cancel his/her booking before 15 days of the travel date because of whatsoever reasons, including accident, sickness, or any other personal reasons, non-payment of the balance payment, the Company is liable to recover Cancellation charges from the Client. All the cancellations must be communicated in written. Advance amount 50% is also non-refundable in case the cancellation is done within 15 days of the travel dates or No Show scenarios.

Advance token amount 25% is non-refundable in any cases.

In exceptional cases like Instant death, company can refund the advance payment amount but only after deducting its service charges. (Please note: Company would also need the death certificate to process the refund amount)

The Company deserves the right to change the package cost depending on the economical status of the market as per the Government policy.

Services will be provided to the customers as mentioned in the booking voucher only.

Any complimentary services (If not provided) cannot be claimed in form of cash or alternative services.

Amendment Policy (Prepone & Postpone)

In case client wishes to prepone /postpone his or her travel dates, we request you to kindly reach us 7 days prior to journey date via e-mail/SMS.

The customers can prepone /postpone their tour once without any additional charges (if intimated before 7 days of travel date in written). However postponing & preponing second time will attract additional charges.

Also note that few service providers (Hoteliers, Transporter etc.) may apply postpone/prepone charges even after meeting above requirement. In such cases postpone/prepone charges will deducted from the advance amount deposited.

In all prepone or postpone scenarios, the services and the costing will be subject to availability of Hotel/Volvo and season/off season time.

We do not accept any changes in plan within 7 days of travel date. However in rare cases like adverse climatic conditions or strikes, package can be postponed which will be intimated to you beforehand.

The validity to utilize your Advance payment in prepone/postpone scenarios is 1 Year from the date of advance payment.

The advance payment and the invoice Number allotted to you, are transferable i.e. you can pass on your booking to any of your friends/ relatives. (Please Note : In order to transfer your booking you must meet the above terms and conditions first).
